## Admissions requirements

The Cert HE in Journalism is open to all who are interested in learning basic practical journalism skills and understanding their professional and cultural contexts.

We welcome applicants without traditional entry qualifications as we base decisions on our own assessment of qualifications, knowledge and previous work experience. We may waive formal entry requirements based on judgement of academic potential.

## Course aims

This programme gives students an introduction to the practice and theory of journalism, with an emphasis on transferable professional skills and critical awareness of the media and creative industries.

Programme aims:

To offer students the chance to develop skills in journalism, to understand the industrial, political and social context of their work, and to evaluate their performance.

To develop students' media culture so that they can put their own and others' work in context, and thus develop their professional capacities and employability.

To develop students' communication, study, written, team-work and performance and creative skills as appropriate, together with students' ability to evaluate their own practice.

## Course structure

In order to be awarded the Certificate of Higher Education in Journalism, students must complete two compulsory 30-credit modules, Journalism in British Life and Introduction to Journalism Practice, as well as 60 credits in optional modules from the list below. Overall students must complete a minimum of 60 credits at level 4 and a maximum of 60 credits at level 5.

## **How you will learn**

Your learning and teaching is organised to help you meet the learning outcomes (below) of the course. As a student, we expect you to be an active learner and to take responsibility for your learning, engaging with all of the material and sessions arranged for you.

Each course is divided into modules. You will find information on the virtual learning site (Moodle, see Academic Support below) about each of your modules, what to expect, the work you need to prepare, links to reading lists, information about how and when you will be assessed.

Your learning for this course will be organised around the activities outlined below.

Learning is student-centred through practical exercises, lecturer presentations, individual and group work, discussion, research, and critical evaluation of practice and skills.

## **How we will assess you**

The course will use a variety of assessment methods. Assessment is used to enhance your learning rather than simply to test it. For most of the modules associated with this course, your assessment will be through the following types of assessment.

Assessment methods range from journalistic articles and essays to strategic plans and critical reflections.

## **Learning outcomes (what you can expect to achieve)**

'Learning outcomes' indicate what you should be able to know or do at the end of your course. Providing them helps you to understand what your teachers will expect and also the learning requirements upon which you will be assessed.

At the end of this course, you should be able to:

### **Subject Specific:**

- Demonstrate awareness of the language and aesthetic practices of journalism and knowledge of the main theories relating to journalistic production;
- Demonstrate understanding the historical, social and political context of media production, markets and institutions.
- Demonstrate understanding of the practice and theory of print culture and electronic multimedia, in a variety of historical, cultural and commercial contexts.
- Demonstrate knowledge of mainstream media forms and alternatives to the mainstream, of media genres and national and international perspectives.

### **Intellectual:**

- Demonstrate ability to learn as well as critique current institutional practices and offer alternatives.
- Analyse texts in different forms of media.
- Assess a wide variety of information in media form, and present them in practical projects

- Critically evaluate practical media work
- Demonstrate ability to evaluate own work critically
- Communicate ideas in different media formats
- Plan own learning and skill development

#### Professional:

- Through practical options – demonstrate skills in journalistic techniques and the communication of ideas in print or electronic form;
- Demonstrate skills in communicating ideas in narrative form;
- Analyse a creative brief and to identify appropriate creative models;
- Analyse the effectiveness of your own creative work.
- Through discussion groups and through team work (journalism, screenwriting) demonstrate ability to work with others and to respect their views.
- Write clearly and concisely
- Demonstrate ability to make informed decisions
- Evaluate appropriate uses of new technologies for researching areas of the media

#### Personal and Social:

- Interpersonal skills such as the ability to work in a group or as a member of a team.
- Communicate effectively using different media and appropriate interpersonal skills
- Take responsibility for own learning and time management
- Work under pressure and to deadlines

### **Careers and further study**

Graduates can pursue career paths in:

- journalism (newspapers and magazines, print, online and digital)
- public relations
- the creative industries.

This course can also provide transferable skills and knowledge to work across a broad range of professional communications roles and settings.

You will also be allocated a personal tutor and provided with information about learning support offered within your School and by the College.

### **Quality and standards at Birkbeck**

Birkbeck's courses are subject to our quality assurance procedures. This means that new courses must follow our design principles and meet the requirements of our academic regulations. Our periodic review process is a regular check (usually every four years) on the courses by department with a specialist team including students.

Each course will have an external examiner associated with it who produces an annual report and any recommendations. Students can read the most recent external examiner reports on the course Moodle pages. Our courses are all subject to Birkbeck Baseline Standards for our Moodle module information. This supports the accessibility of our education including expectations of what information is provided online for students.
